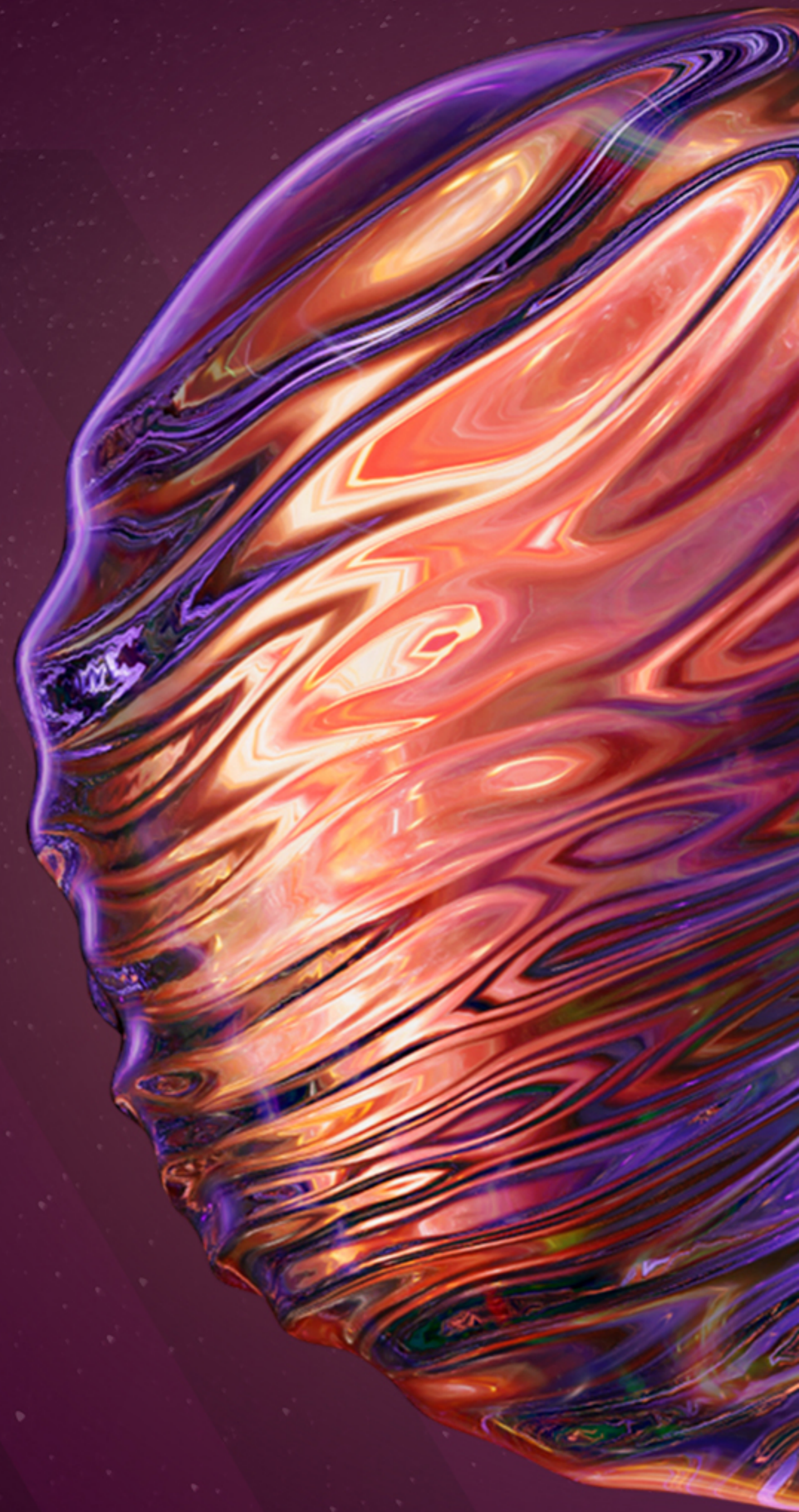

# Problems

of the classic investment market:



## High transaction costs

The cost of transactions and fees charged by intermediaries in classical financial markets are so high that they often “eat up” a considerable share of the margin.



## Lack of transparency

The transparency of financial institutions is not properly ensured for small investors, and large financial institutions benefit from this.



## Slow operations

Red tape and outdated technical solutions fail to provide the proper speed of response to market events, which is a must today.



## High overhead costs

The costs and fees are significantly higher with small investments in percentage terms than with large investments, which reduces return.

Antoreum personal account allows to control investments and submit orders for fast withdrawals. The entire process is clear and transparent.



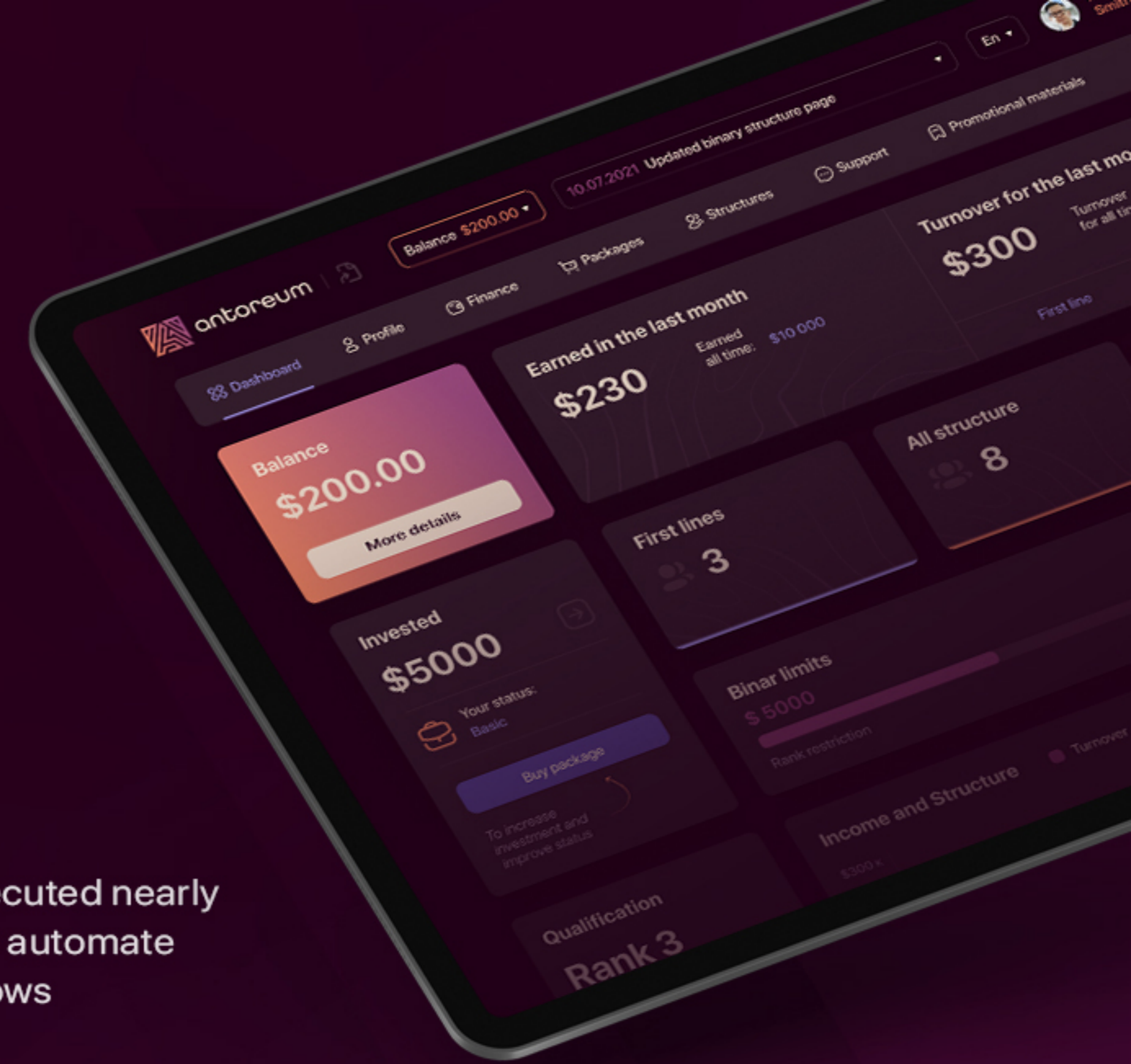
## Process automation

# Marketing strategy

The market entry marketing strategy will be implemented in the next year and a half in two stages:

1. After the final product packaging and the localization procedure, the service will gradually open up to investors from the EU, the Russian Federation, Ukraine, Belarus, and Kazakhstan in the first wave.
2. The expansion will continue once all business hypotheses are finally confirmed and a stable community is formed, and the second wave will cover the UAE, China and South Korea markets.

The project team is planning an extensive road-show as part of a separate set of events, its timeline is to be presented separately. Multi-tier incentive and reward systems are provided for active participants and ambassadors of the project; the detailed information is presented below in this presentation.

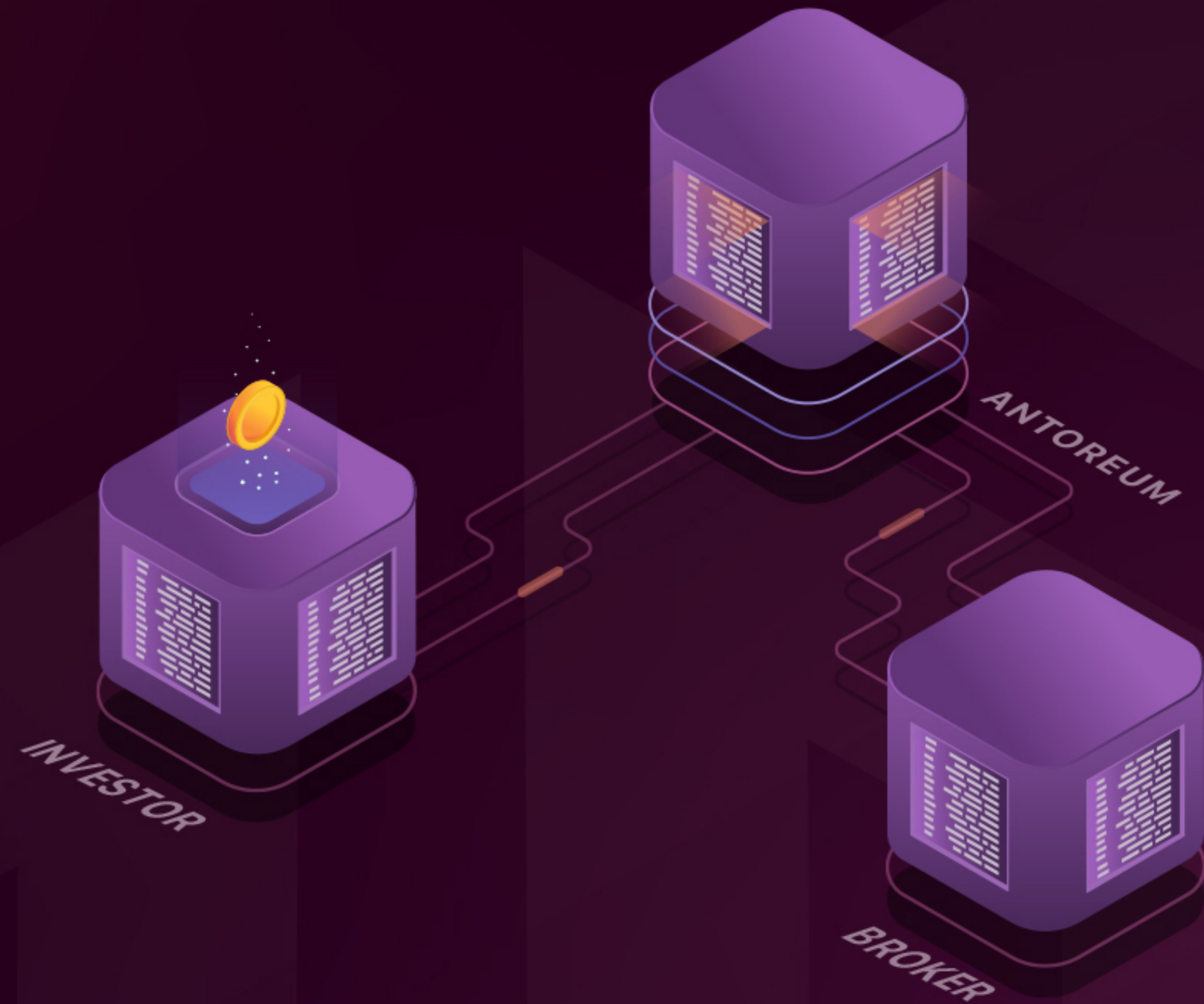

# Ecosystem

The Antoreum architecture is based on the use of a segregated account mechanism.

Each user of the service manages their account (financial portfolio) independently; the accounts are aggregated by the Antoreum software, and the sum of funds is balanced and invested in highly profitable instruments from Avocado Tree.

Once the daily profit is fixed, the system distributes it among all participants, reflecting it inside the personal account. You just need to withdraw or reinvest the funds you earned.



# Avocado Tree

The Antoreum team realized this, and therefore acquired support and entered into an exclusive partnership agreement with the European broker Avocado Tree.

# Options of getting income

**Investment income** – is profits obtained by the partner from the acquired investment programs.

**Income from the incentive program** – is payments for inviting new partners to the project and developing a partnership structure.



# Investment programs

Antreum opens up opportunities for investors with different investment potential.

The company extracts the largest available profit for each participant in joint investment activities by combining funds into large pools

Duration of all programs is **300 days**

Daily profit interest is **from 0.8% to 1%**

The number of programs **is not limited**

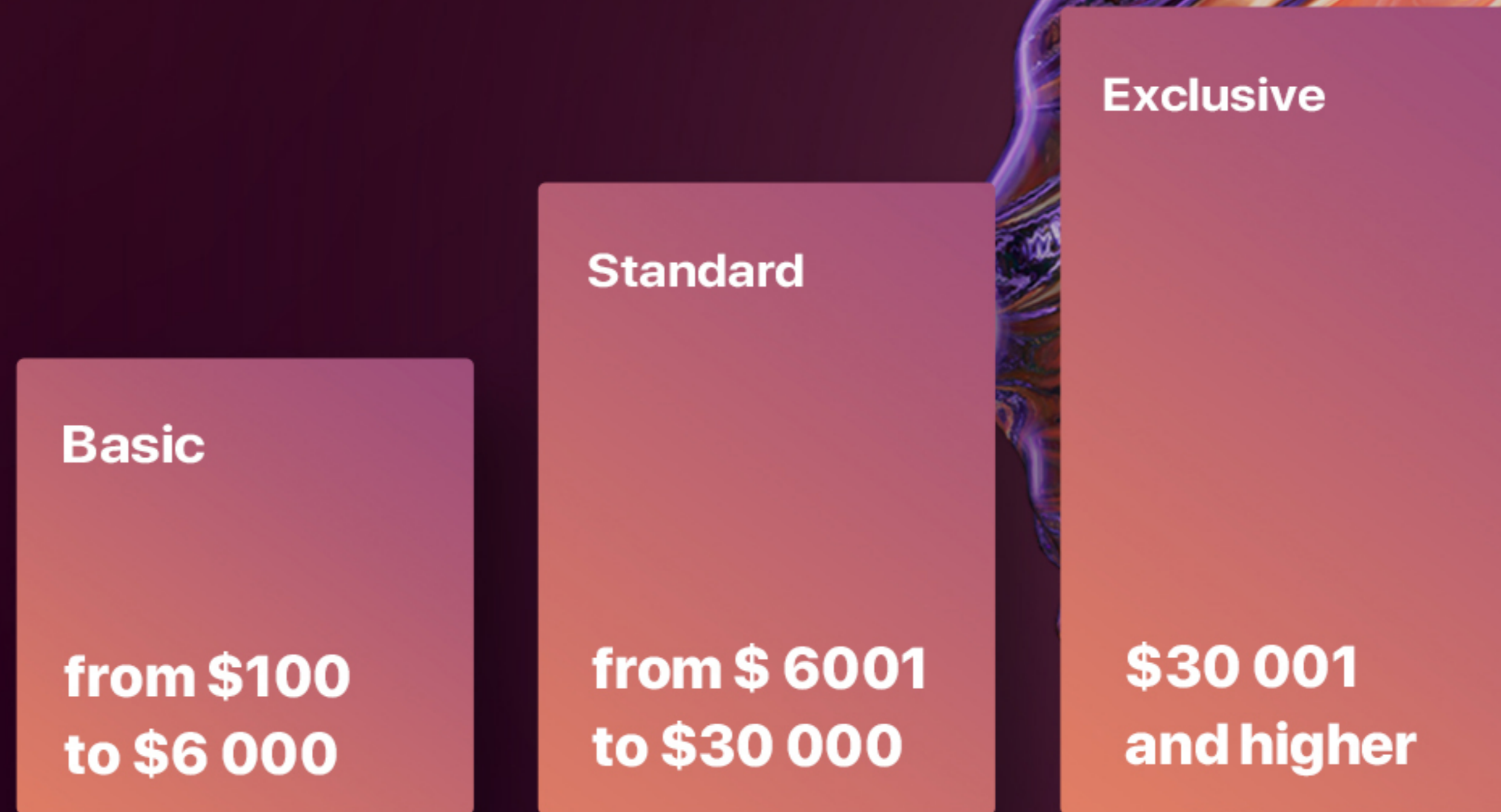


# Incentive program

Each partner is assigned a certain status in the incentive program

The status depends on the total amount of the partner's investment programs

The status defines the size of payments in various types of remuneration in the incentive program.

This type of remuneration is accrued instantly at the moment the partners from your investment program structure make payments.

The percentage from the payment amount is accrued.

A personal structure is created by registering partners using a referral link.

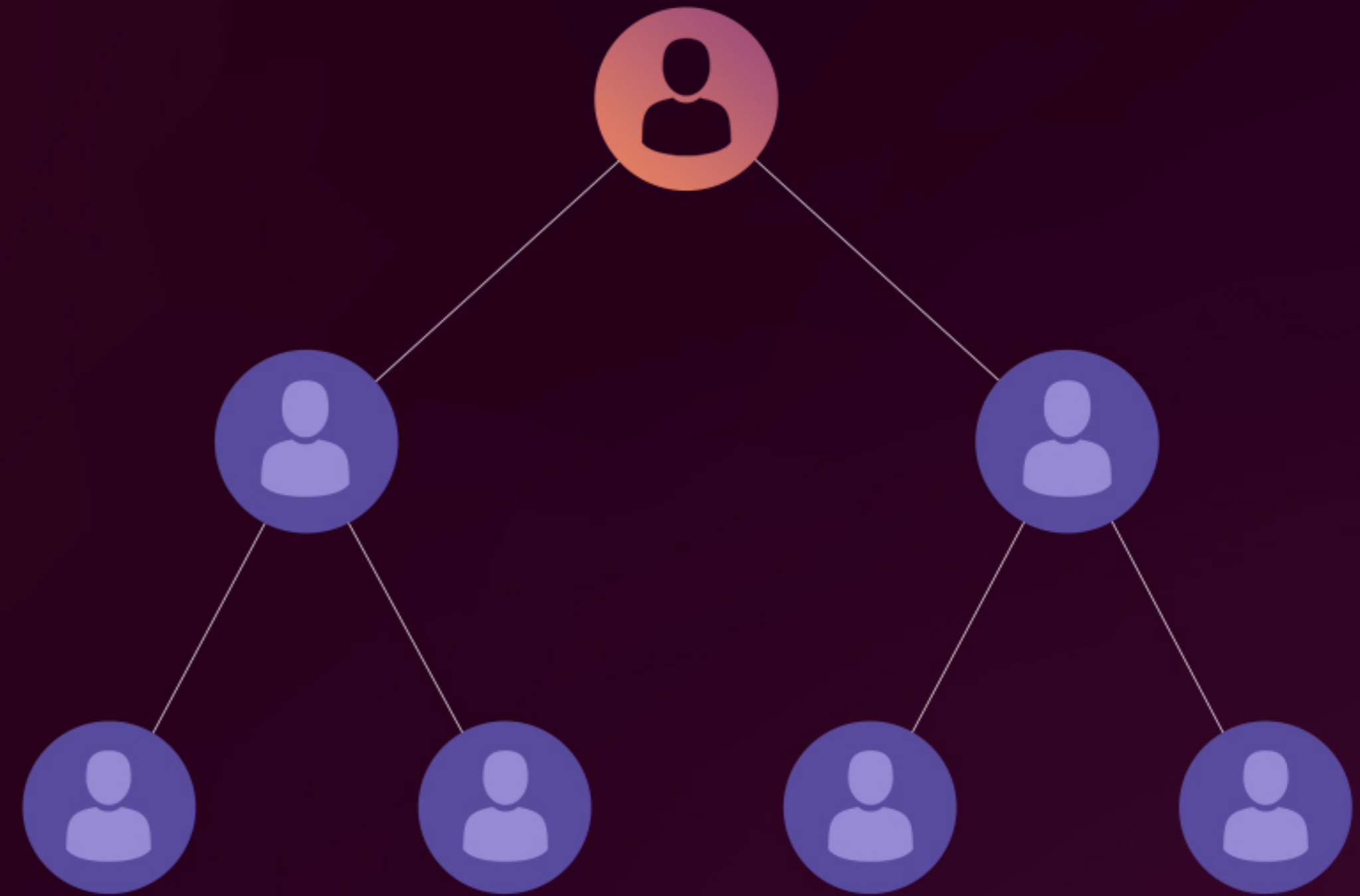
Partners who register using your link form your 1st tier.

# Binary bonus

Status	Payments from the small leg
Basic	10%
Standard	11%
Exclusive	12%

This type of remuneration is accrued daily at midnight. The binary reward is calculated as follows: Once a day, the program sums up the volumes of purchased investment programs in the left and right branches of the binary tree. Then the program calculates a percentage corresponding to your status from a smaller branch.

The same amount is deducted from your larger structure. The amount of the larger branch remaining after the deduction is retained. The maximum size of a binary bonus is determined by the amount of your personal investment or the qualifying rank you have achieved.



The binary structure is formed automatically. The partner can choose the regulation of the placement of new partners to the left or right branch in the personal account.

# Regulations of the Antoreum platform

1. All transactions are made in USDT (ERC20 and TRC20).
2. The network fee for deposit and withdrawal is paid by the user of the Antoreum platform.
3. Requirements for withdrawal:
  - a. The minimum withdrawal amount is \$10.
  - b. The request processing time is not more than 48 hours.
  - c. You cannot create more than one active withdrawal request at a time.
4. Internal transfers are not available in the system.
5. There are 2 limits in the system required for the stable operation of the platform:
  - a. The maximum withdrawal amount per week is 100% of your investment amount.  
For example, if you invested \$1,000 but earned \$1,200 on our website, you can withdraw \$1,000 in the first week and \$200 in the next week, respectively.
  - b. The maximum income for a binary bonus is limited and depends on the rank you have reached.  
However, the income received in excess of the limit is not lost — it remains as a frozen balance in our system.  
Once you have advanced with your rank in the system, you instantly withdraw from the frozen balance to the regular one.
